January 2, 2008

The regular meeting of the City Council of the City of Pittsfield, Pike County, Illinois, was held on Wednesday, January 2, 2008, at 6:00 p.m. The meeting was held at the City Council room at 215 North Monroe Street. The purpose of the meeting was to transact any business legally brought before it. The following officers were present: Mayor John Hayden, City Clerk Cindy Prentice, and Aldermen Dan Chamberlain, Richard Ervin, Paul Lennon, Larry Ruble, Bill Scheiwe, Kevin Wombles, and Robert Wood.

Absent: Alderman Robert Wilson.

Mayor Hayden presided.

Alderman Scheiwe moved to approve the minutes of the last regular Council meeting.

Alderman Ruble seconded the motion.

The motion was tabled due to a question raised by Alderman Ervin concerning changing his vote on the liquor license ordinance at the last regular Council meeting from yes to no.

Alderman Wombles moved to accept the recommendation of the Zoning Committee to approve the Special Use Permit for Marva Hurst, prospective owner of the property located on 390th Street, for operation of a boarding kennel for dogs on the property.
